The S&P 500 Composite was created and incepted on September 1, 2015. The U.S. Dollar is the currency used to express performance. The minimum account size for this composite is \$25,000.

The investment management fee schedule for the composite is 1% on the first \$250,000, 0.80% for \$250,001 to \$1 million, 0.65% for \$1,000,001 to \$5 million, and 0.50% for assets over \$5 million. Actual investment advisory fees incurred by clients may vary. Further information regarding investment advisory fees is described in Part II of the firm's Form ADV.

The benchmark is the S&P 500 Index. The S&P 500 is a free-float capitalization-weighted Index published since 1957 of the prices of 500 large-cap common stocks actively traded in the United States. The stocks included in the S&P 500 are those of large publicly held companies that trade on either of the two largest American stock market exchanges; the New York Stock Exchange and the NASDAQ. One cannot invest directly in an index.
