The 50/50 Composite contains portfolios approximately invested 50% in equity mutual fund holdings and approximately 50% in bond mutual fund holdings. The 50/50 Composite was created and inceptioned on July 31, 2009. The U.S. Dollar is the currency used to express performance. The minimum account size for this composite is \$25,000. The investment management fee schedule for the composite is 1% on the first \$250,000, 0.80% for \$250,001 to \$1 million, 0.65% for \$1,000,001 to \$5 million, and 0.50% for assets over \$5 million. Actual investment advisory fees incurred by clients may vary. Further information regarding investment advisory fees is described in Part II of the firm's Form ADV. The custom benchmark uses a 50/50 blend of the MSCI ACWI - Net (50%) and the Barclays Global Aggregate Bond Index (50%) indices rebalanced monthly. The MSCI ACWI Index is a free float-adjusted market capitalization weighted index that is designed to measure the equity market performance of developed and emerging markets. The MSCI ACWI consists of 44 country indices comprising 23 developed and 21 emerging market country indices. The Barclays Global Aggregate Bond Index provides a broad-based measure of the global investment grade fixed-rate debt markets. It is comprised of the U.S. Aggregate, Pan-European Aggregate, and the Asian-Pacific Aggregate Indexes. It also includes a wide range of standard and customized subindices by liquidity constraint, sector, quality, and maturity. Past performance is not indicative of future results.
