The 0/100 Composite contains portfolios approximately invested 100% in bond mutual fund holdings. The 0/100 Composite was created and incepted on January 31, 2010. The U.S. Dollar is the currency used to express performance. The minimum account size for this composite is \$25,000.

The investment management fee schedule for the composite is 1% on the first \$250,000, 0.80% for \$250,001 to \$1 million, 0.65% for \$1,000,001 to \$5 million, and 0.50% for assets over \$5 million. Actual investment advisory fees incurred by clients may vary. Further information regarding investment advisory fees is described in Part II of the firm's Form ADV.

The benchmark is the Barclays Global Aggregate Bond Index. The Barclays Global Aggregate Bond Index provides a broad-based measure of the global investment grade fixed-rate debt markets. It is comprised of the U.S. Aggregate, Pan-European Aggregate, and the Asian-Pacific Aggregate Indexes. It also includes a wide range of standard and customized sub-indices by liquidity constraint, sector, quality, and maturity.
